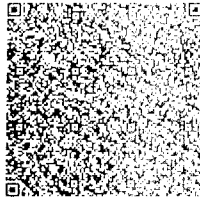

This Memorandum of Understanding (MOU) is entered into on this the (Date: 15/10/2023) by and

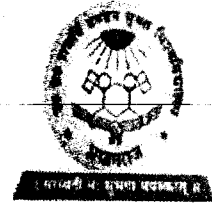
