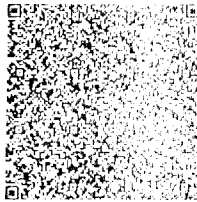

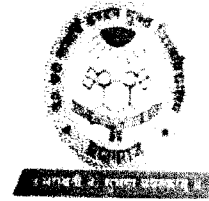

CLAUSE -1 CO-COPERATION

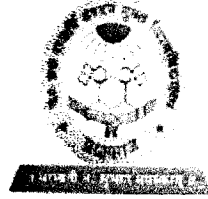
- 1.1 Both the parties are united by common interests and objective, and they shall establish co-operation.
