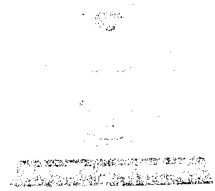
This Memorandum of Understanding (MOU) is entered into on this the (Date:03/06/2023) by and

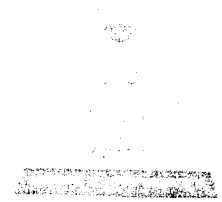
